# LAUNCHED!! NEW GARP Accomplishments Reporting Modules



The GARP Team is excited to announce that, starting today, GARP becomes the official NASF accomplishments reporting platform for USFS Cooperative Fire grants funding the implementation of the National Cohesive Wildland Fire Management Strategy. The adoption of GARP by States as an accomplishments data repository is a ground-breaking initiative that will help NASF and the USFS quantify and communicate the collective investment being made nationwide.

#### Who is this for?

State Forestry Staff who report accomplishments for Coop Fire Grants above are invited to request a GARP account with the Grant Manager role in appropriate modules, as authorized by your agency. If you already have a GARP account, the GARP Team has already added your new roles based on information provided by your State Forester or Fire Program Manager. If you think you need access as a Grant Manager and are only seeing 'Viewer' access, please contact GARP Support and COPY your Fire Program Manager so we can expedite the authorization. NASF, State Forestry and USFS staff may also request access with the 'Viewer' role to explore or get insights into reported accomplishments.
